

# CONTEST RULES

*Travel Vacation Voucher Giveaway ("Contest")  
from January 10, 2024 to September 30, 2024 ("Contest Period")  
Adult Lifestyle Communities ("ALC")*

## 1. HOW TO ENTER

**No purchase required.** To enter the Contest, visit [AdultLifestyleCommunities.com](https://AdultLifestyleCommunities.com) during the Contest Period.

To enter, the contestant must complete the contest entry form during the Contest Period. (the "**Contest Rules**") To be valid, all entries must be received by September 30, 2024.
